### अधिसूचना

**सा. का.नि. 176(अ).**—केन्द्रीय सरकार, सूचना प्रौद्योगिकी अधिनियम, 2000 (2000 का 21) की धारा 87 द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, सूचना प्रौद्योगिकी (प्रमाणकर्ता प्राधिकारी) नियम, 2000 में और संशोधन करने के लिए निम्नलिखित नियम बनाती है, अर्थात् :-

1. संक्षिप्त नाम और प्रारंभ :- (1) इन नियमों का संक्षिप्त नाम सूचना प्रौद्योगिकी (प्रमाणकर्ता प्राधिकारी) संशोधन नियम, 2019 है।

(2) ये राजपत्र में उनके प्रकाशन की तारीख को प्रवृत्त होंगे।

2. सूचना प्रौद्योगिकी (प्रमाणकर्ता प्राधिकारी) नियम, 2000 की अनुसूची 4 में, प्ररूप ग के स्थान पर निम्नलिखित प्ररूप रखा जाएगा, अर्थात् :-

**G.S.R. 176(E).**—In exercise of the powers conferred by section 87 of the Information Technology Act, 2000 (21 of 2000), the Central Government hereby makes the following rules further to amend the Information Technology (Certifying Authorities) Rules, 2000.

1. **Short title and Commencement.**—(1) These rules may be called the Information Technology (Certifying Authorities) (Amendment) Rules, 2019.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Information Technology (Certifying Authorities) Rules, 2000, in Schedule IV, for Form C the following Form shall be substituted, namely:—
